## **Volunteer Agreement**

This Release and Waiver of Liability (“Release”) executed on this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by \_\_\_\_\_ Deborah Shapley, President, in favor of Restore Mass Ave, a nonprofit corporation organized and existing under the laws of the District of Columbia, USA, its successors and assigns, and each of its past, present, and future directors, officers, employees, and agents (collectively, “RMA”). I, the undersigned volunteer (“volunteer”), desire to work for RMA in a volunteer capacity and hereby freely and voluntarily, without duress, execute this Release under the following terms:

**Assumption of Risk.** I, the volunteer, acknowledge that work with RMA involves potentially hazardous and strenuous activities. I, the volunteer, acknowledge that I am fully aware of any and all risks associated with these volunteer activities with RMA. I, the volunteer, hereby state that I am assuming all such risks and that therefore RMA will not be liable for any injuries or damage occurring as a result of participation in such volunteer activities.

**Medical Condition.** I, the volunteer, warrant that I have no condition preventing me from engaging in volunteer activities. Should a change in my medical or physical condition develop or appear to be developing, I, the volunteer, may consult a physician prior to continuing to perform volunteer activities with RMA, or I may continue performing activities of my own volition, releasing RMA from any liability therefor.

**Medical Treatment.** I, the volunteer, hereby release and forever discharge RMA from any claim which arises or may arise on account of any first-aid treatment or other medical services rendered in connection with my volunteer activities with RMA.

**Waiver and Release.** In exchange for the opportunity to engage in volunteer activities for RMA, I, the volunteer, on behalf of myself, my estate and my heirs and assigns, hereby willingly release and forever discharge and hold harmless, as well as agree to defend and indemnify, RMA, its successors and assigns, as well as all of its past, present and future directors, officers, agents, and employees (“Releasees”) from any and all liability, claims, demands, injuries, damages, actions, or causes of action, of whatever kind of nature, either in law or in equity, which arise or may hereafter arise in connection with my volunteer activities for RMA to the fullest extent permitted by law.

**No Promise of Employment.** I, the volunteer, acknowledge that my volunteer activities with RMA does not create a promise of nor an expectation of employment with RMA or entitlement to special consideration or rights or compensation of any kind.

**Photographic Release.** I, the volunteer, grant and convey unto RMA all right, title, and interest in any and all photographic images and video or audio recordings made during my work with RMA with no compensation due me.

**Other.** I, the volunteer, expressly agree that this Release is intended to be as broad and inclusive as permitted under the laws of the District of Columbia in the United States of America, and that this Release shall be governed by and interpreted in accordance with the laws of the District of Columbia. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court or tribunal of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release, which shall continue to be enforceable.
