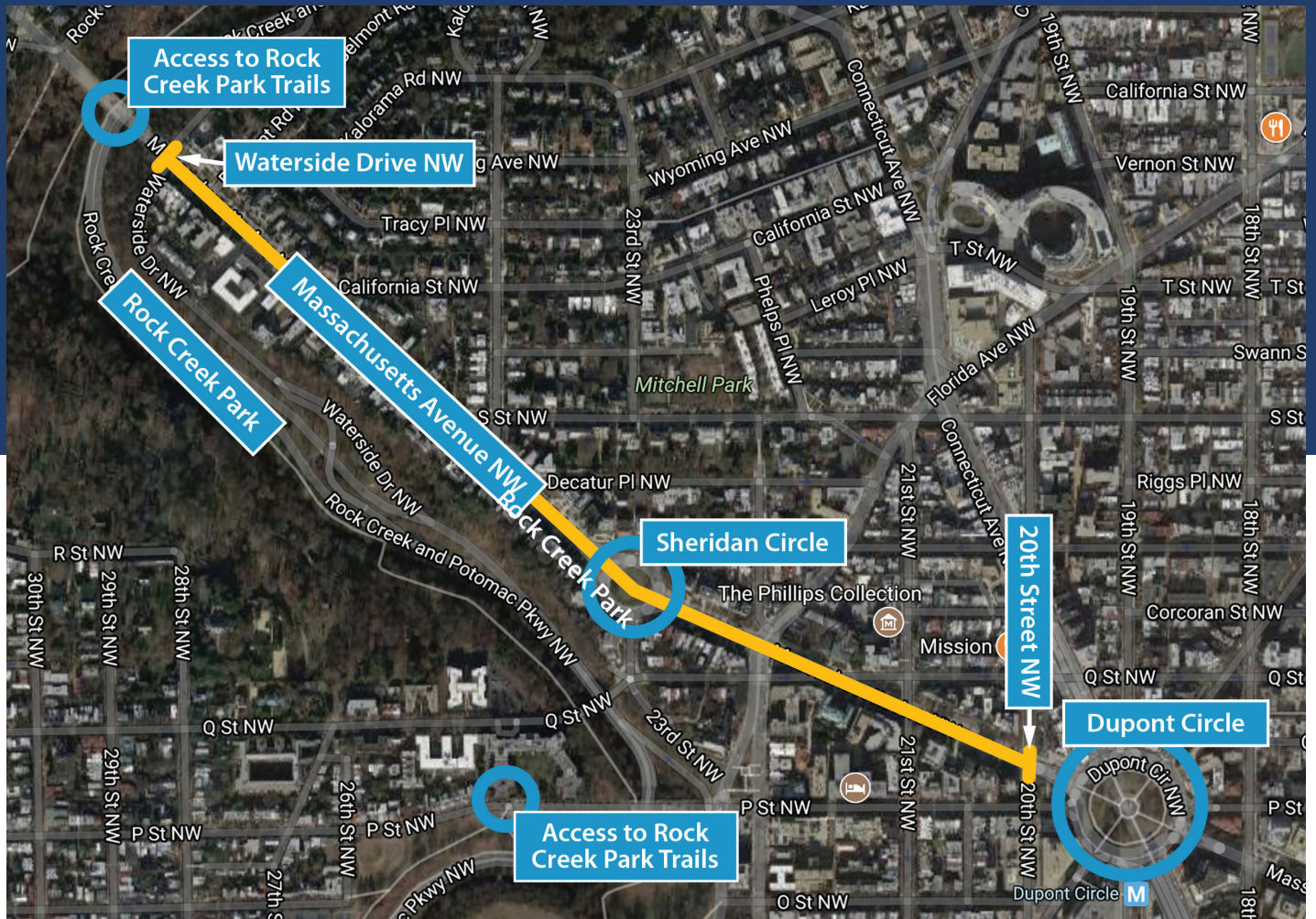

# Rehabilitation of Massachusetts Avenue NW (from 20th Street to Waterside Drive)

### PROJECT OBJECTIVE

The purpose of this project is to reconstruct extended sections of the Massachusetts Avenue NW corridor to replace old pavement. Additionally, the project will improve the corridor's overall streetscape including upgrades to street lighting and traffic signals, landscaping, and ADA accessibility.

### PROJECT BACKGROUND

Massachusetts Avenue NW, also known as Embassy Row, is a historic corridor and a principal arterial in the District. DDOT is working to create a safer corridor for motorists, bicyclists and pedestrians while preserving and enhancing the historic identity of Massachusetts Avenue NW. The existing roadway section of the corridor was originally constructed in the 1950s. The current roadway pavement subgrade has deteriorated over time and requires repeated resurfacing to maintain the road in a drivable condition. The project will reconstruct Massachusetts Avenue NW from 20th Street to Waterside Drive, except for a 950-foot section near Sheridan Circle that will be resurfaced. Construction is anticipated to begin in March 2021.

### PROJECT IMPROVEMENTS

- Mill and overlay or reconstruction of pavement
- Reconstruction of sidewalks, curbs and gutters
- Reconstruction of existing refuge islands (Sheridan Circle and Florida Avenue)
- Upgrades to streetlights and traffic signals
- Upgrades to drainage structures
- ADA compliance
- Perform best practice for stormwater management including LIDs (bioretention)
- Upgrades to landscaping with trees
- Furnish and install street furniture (benches, trash cans, etc.)
- Intersection safety improvements
